- i) Generally on such object of charity and public good as the Trustees may think proper and those which are covered by the definition of 'Charitable purpose' as per the provisions of sec 2 (15) of the Income-tax Act, 1961, with all the statutory modifications and amendment thereof made from time to time.

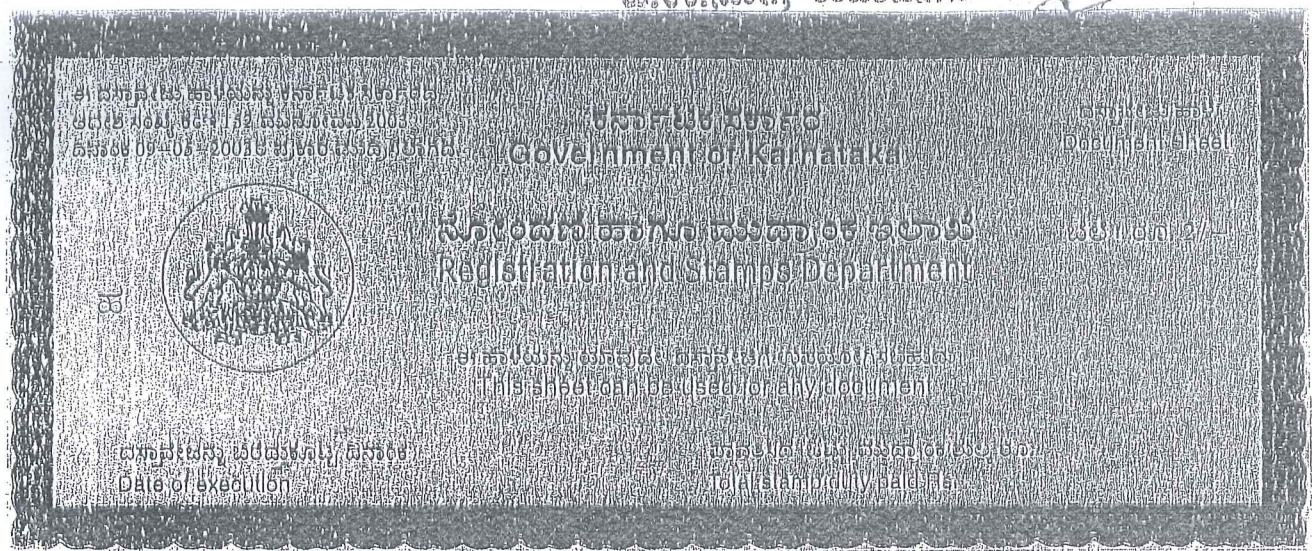

7. ACCOUNTING YEAR: The accounting year of the Trust shall be from 1st day of April to 31st day of March, every year. However, the accounts for the first year i.e., from the date of creation of the Trust to 31st day of March, Two Thousand Eight shall be made though it is a broken period.

8. MANAGING COMMITTEE:- All the Trustees constitute themselves as the Managing Committee for managing the affairs of the Trust. The Managing Committee shall be empowered to make all appointments of staff, both teaching and non-teaching for its various institutions. The Managing Committee shall also have power to remove, suspend or dismiss the staff when the circumstances warrant. It shall also have powers to purchase land and building, construct and also to sell, lease, mortgage the properties of the Trust. The Managing Committee shall also have powers to acquire land and building and /or any other moveable or immovable property on lease or rent. The managing committee shall also have power to obtain overdraft facilities in Bank or Banks and / or from any financial institutions. It shall also have powers to invest funds of the Trust in Debentures, Fixed deposits, National saving Certificates and in any other form of securities as may be decided by the Trustees from time to time in the interest of the Trust.

9. MANAGING TRUSTEE: Sri L.S. Shama Sundara Sharma the first Trustee of the Trust shall be the Managing Trustee of the Trust. In case of resignation of the Managing Trustee, or on account of death, insolvency, insanity or otherwise the vacancy shall be filled up by nomination of the legal heirs of the Managing Trustee.

11. **BORROWINGS:-** The Managing Trustee is empowered to raise loans or borrow funds from Banks and financial institutions and also from individuals and to give properties of the Trust as securities for the betterment of the Trust and for fulfilling its objectives.

12. **MEETING :** The Managing Committee of the Trust shall ordinarily meet once in every three months or at any time with prior notice of one week to review the working of the Trust and to transact any other business of the Trust.

13. **DURATION OF THE TRUSTEES:** (1) The first and the second trustees of the Trust shall be for life.

14. **NOMINATION /CO-OPTION OF TRUSTEES:**
The Managing Trustee shall have powers to nominate /Co-opt the Trustees and the duration of the such nominated /Co-opted Trustees shall be for a prescribed period not more than 5 years and further they are entitled for co-option/nomination by the Managing Trustee again.

15. **NUMBER OF TRUSTEES:-** The maximum number of Trustees shall not exceed five and however when the circumstances warrant and in the interest of the Trust, the Managing Trustee shall have powers to increase the number of Trustees at his choice.

16. **POWERS AND DUTIES OF THE MANAGING TRUSTEES:** - The Managing Trustee shall be vested with all the powers to transact the business of the Trust in the interest of the Trust and shall be accountable to the Managing Committee.

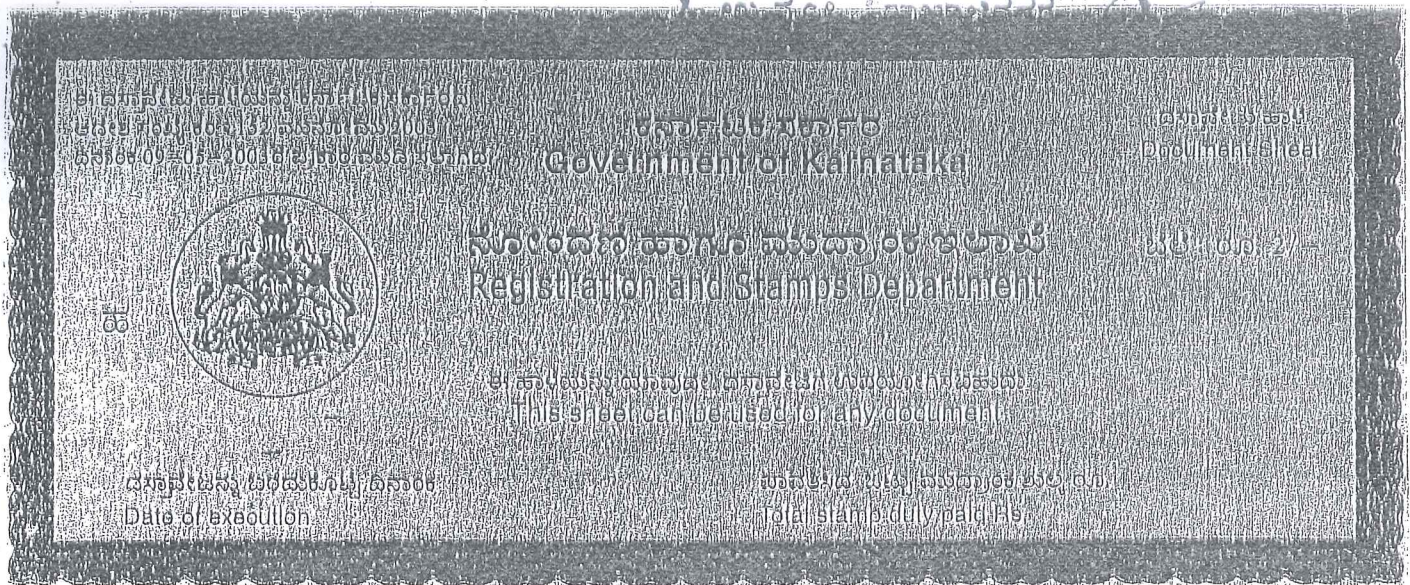

18. ACCOUNTS OF THE TRUST:- The accounts of the Trust shall be maintained regularly.

19. AUDIT OF ACCOUNTS: The accounts of the Trust shall be got audited by a Chartered Accountant and financial statements so prepared shall be presented to the Managing Committee for its consideration at the annual meeting.

20. ANNUAL GENERAL MEETING: The Annual General Meeting of the Trust shall be held after the close of the accounting year.

21. CEASURE OF TRUSTEESHIP: The Trusteeship of any Trustee shall cease on the happening of the following events.

- a) on resignation of any Trustee
- b) on the death of any Trustee
- c) on the insanity of any Trustee
- d) on the insolvency of any Trustee declared by a Competent Court.
- e) Misbehavior of any Trustee on a resolution passed by other Trustees.

22. JURISDICTION: The Jurisdiction of the Trust for achieving its objectives shall be the entire State of Karnataka and also the other parts of India .



23. **APPLICATION:** The Trust shall be bound by the regulations of the Indian Trust Act in all the matters relating to Trust.

24. **INVESTMENT CLAUSE:** -The funds of the Trust shall be invested in the modes as specified under the provisions of Section 13 (i)(d) read with Section 11(5) of the Income-tax Act, 1961, as amended from time to time.

25. **AMENDMENT:** No amendments to the Trust deed shall be made which may prove to be repugnant to the provisions of Section 2(5), 11, 12, 13 and 80-G of the Income-tax Act, 1961 as amended from time to time.

26. **DISSOLUTION:** In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed to the Trustees but the same shall be transferred to any other charitable trust whose objects are similar to those of this Trust and which enjoys recognition under Section 80-G of the Income-Tax Act, 1961, as amended from time to time.

27. **IRREVOCABLE:** The Trust formed shall be irrevocable.

28. **BENEFITS:** The benefits of the Trust shall be irrespective of caste, creed, colour, religion or sex.

29. **APPLICATION OF THE FUNDS:** The funds and income of the Trust shall be solely utilized for the achievement of the objects and no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividend etc.,

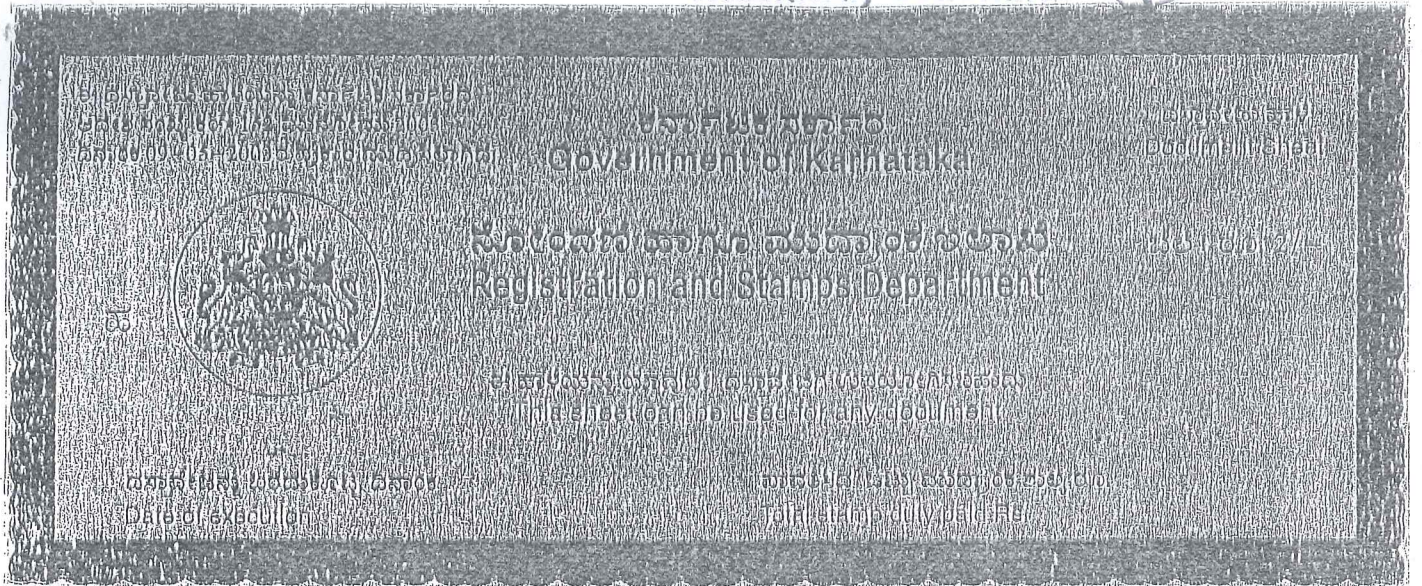
